CRITERIA FOR CONFERRING LIFE MEMBERSHIP

### CATEGORY A

A BONA FIDE, PAID UP AND ACTIVE MEMBER
OF THE CLUB FOR A MINIMUM PERIOD OF TEN YEARS,
WHETHER PLAYING OR NON-PLAYING.

## CATEGORY B

- APPOINTED AND PERFORMED MANAGEMENT COMMITTEE DUTIES FOR A MINIMUM PERIOD OF TEN YEARS.
- APPOINTED AND PERFORMED EXECUTIVE COMMITTEE DUTIES FOR A MINIMUM PERIOD OF SEVEN YEARS.
- PLAYED A MINIMUM OF 120 SENIOR MATCHES.
- COACHED THE CLUB AND/OR CAPTAINED ONE OF THE TEAMS FOR A MINIMUM PERIOD OF FOUR FULL SEASONS.
- MADE PERSONAL CONTRIBUTIONS OF AN UNDENIABLE AND SIGNIFICANT BENEFIT TO THE CLUB OVER A MINIMUM PERIOD OF TEN YEARS.



## BELLVILLE CRICKET CLUB

CRITERIA FOR CONFERRING LIFE MEMBERSHIP

### CATEGORY C

A MEMBER HAVING CONTRIBUTED FOR FIVE YEARS
IN A LESSER ADMINISTRATIVE, FINANCIAL OR COACHING ROLE.
A MEMBER WHO HAS SERVED ON THE CLUB'S EXECUTIVE
OR MANAGEMENT COMMITTEE FOR A MINIMUM OF FIVE YEARS.

### MINIMUM QUALIFICATION

- MUST HAVE ATTAINED THE CATEGORY A CRITERION AS WELL AS THREE CATEGORY B ACHIEVEMENTS.
- MUST HAVE ATTAINED THE CATEGORY A CRITERION AS WELL AS TWO CATEGORY B AND ONE CATEGORY C ACHIEVEMENTS.

IF A PROSPECTIVE AND WORTHY MEMBER COMPLIES WITH THE CRITERIA FOR LIFE MEMBERSHIP, THEN SUCH MEMBERSHIP SHALL NOT UNDULY BE WITHHELD.

LIFE MEMBERSHIP IS ABSOLUTELY FORFEITED UPON ANY FAILURE TO OBSERVE
ANY CLUB BY-LAW OR CONSTITUTIONAL REQUIREMENTS. A SPECIAL RESOLUTION PASSED BY
THE MANAGEMENT COMMITTEE FOR THE REMOVAL OF LIFE MEMBERSHIP,
SHALL BE AFFECTED DUE TO EXTREME REASONS NOT LIMITED TO,
BUT BY BRINGING THE NAME OF THE CLUB INTO DISREPUTE.
